



Lumber for Export from Russia (to Europe and China)



Dear colleagues!

On behalf of the manufacturer, we offer you the **supply of LUMBER for export from Russia** (to Europe and China). Production is conducted on own equipment, with the wishes of the customer. The supply contract will be signed with the manufacturer, without intermediaries and brokers.

Wood:	Pine, spruce, fir, larch, birch, aspen.
Commodity items:	Edged and not edged board, timber, rail.
Humidity:	Natural and chamber drying (12, 16, 18%).
Molded products:	Lining, blockhouse, imitation of timber, decking, deck board, floor board, planed board.
Packing:	In a film and transport packages, trimming is necessary. Antiseptic processing of lumber is possible (by order).
Scope of delivery:	From 31m ³ to 10,000m ³ per month.
Shipment period:	Every day, according to a pre-agreed schedule.
Production:	Gatchina, Pskov, Kansk, Krasnoyarsk, Yekaterinburg.
Delivery regions:	Deliveries are possible both in Russia and for export to Europe and China.

Currency of payment: Rubles, Dollars, Euros, Yuan.

Form of payment:

- Prepayment under the guarantee of our bank on the return of the advance payment;
- Payment upon loading / delivery;
- SBLC / Letter of Credit with opening upon shipment of goods and the provision of a complete set of shipping documents.

Our equipment:

Wood sawing is produced on modern, fully automated sawing disc lines of high performance "Altai".

Planing of timber is made on modern, four-Sided longitudinally milling machines of the "Beaver pro" series, with the system of automatic reception of the workpiece and the production of finished lumber.

Technological equipment of the company "KATRES" (Czech Republic). Each drying chamber has a processing capacity of 600 m³ of dry lumber per week (2,400 m³ of dry lumber per month).

Application for supply of Lumber

In order for us to form you a commercial offer for the supply of lumber, we ask you to send an Letter of Intent (LOI) on the letterhead of the buyer's company, indicating all the details of delivery.

Lumber issues:

1. What kind of lumber are you interested in? (edged board, timber, rail, mouldings, ...)
2. What kind of wood is required? (Pine, Spruce, Fir, Larch, Birch, Aspen, ...)
3. What are the required dimensions of the cross section and length?
4. How many cubic meters are required for each type of lumber?
5. What percentage of humidity is required? (12%, 16%, 18%, ...)
6. Natural or kiln dried?
7. What kind of packaging is required? (in the film and in transport packages, ...)
8. Is antiseptic treatment of lumber required?

9. What is the quantity of goods in delivery?
10. Will it be a one-time supply contract? Or will there be periodic delivery?
11. What will be the quantity per month? Per year? Total volume?

12. You will carry out the delivery, or we should calculate it in the price?
13. What is the basis of delivery? (DAP - to place, EXW - ex-warehouse, ...)
14. To what place will delivery be required?

Questions about the company to the buyer:

1. Send us Company Profile or Company Information Sheet (CIS) of the buyer's company.
2. Who will sign the contract? (specify the name of the Director)
3. How can we contact him to confirm the order? (tel / whatsapp / viber / IMO / skype / wechat / email ...)

4. What will be the form of payment? (prepayment, upon loading, letter of credit, SBLC)
5. What will be the payment guarantee? (if not prepayment)
6. Will payment be made in Cash or by Bank transfer?
 - a. Will Payment be made from the details specified in the CIS?
 - b. Servicing bank.
 - c. What is the payment currency? (Rubles, Dollars, Euros, Yuan)

7. Website of the buyer's company (so that we can get acquainted with the company)
